LBFE hosted 75 social events (birthday parties, bingo, holiday meals, etc.) for isolated elders. Cross-program accomplishments: 3,839 in-person visits, 2,955 phone visits, 879 written correspondences, 1,444 rides and 2,791 nutritious meals. Services were supported by 691 active volunteers providing 7,002 service hours.
